

MEMBER FEES

SET-UP FEES FOR NEW MEMBER CODES (A.K.A. DATABASES)

- New Member Code: \$369.00
 - Additional Member Code: \$153.00
- New Design Member Code: \$369.00
 - Additional Design Code: \$153.00

Annual maintenance fees of \$51.52 per database apply upon the first full year of membership.

REMOTE MEMBER ACCESS (RMA) ACCOUNTS

The Remote Member Access program provides member with access to databases via the following account types:

- RMAA – Administrator
- RMAF – Full Access
- RMAL – Limited
- RMAM - Mapping
- RMAP – Positive Response
- RMAS – Search

Annual maintenance fees of \$38.55 per account apply upon the first full year of membership.

TRANSMISSION FEES

- Base Fee: \$570 (covers the first 500 transmissions on a billable code)
- Transmission Fee: \$1.15 (applies to each transmission over 500 on a billable code)

Transmissions fees are billed annually.

- Ticket count by code (for any period six months or less): \$13.50 per ticket type

- Specific Positive Response statistics by code (for any period six months or less): \$37.00

MAPPING ASSISTANCE

- The first three hours of assistance are free.
 - Additional hours: \$49.00 per hour

FAX DELIVERY

- There is an additional transmission cost for fax transmissions of \$4.41 per transmission.
 - This applies to primary and/or alternate delivery.

EDUCATION FEE

- Only facility owner/operator members are charged an Education fee, which is specifically used to publicize and educate (a system requirement under Section 6(2) of PA 174). The education fee is billed annually based on the total amount paid for annual membership. This applies to primary and/or alternate delivery.
 - Scale
 - \$1,000 or less = \$100
 - \$1,001 to \$2,500 = \$250
 - \$2,501 to \$5,000 = \$500
 - \$5,001 to \$10,000 = \$1,000
 - \$10,001 to \$25,000 = \$2,500
 - \$25,001 or more = \$5,000
